Dear Sirs,

Please find herewith a copy of the approved Draft Schedule(s) for the above-mentioned event(s); a copy of it/them must be forwarded to the Organising Committee(s) upon receipt.

The corrections and remarks on the approved Draft Schedule(s) must be incorporated by the Organising Committee into the Definite Schedule(s). The words "Approved by the FEI", followed by the date of approval, must be printed on the Definite Schedule(s). The FEI must receive a copy of the Definite Schedule(s), **no later than four weeks before the event starts**. A copy must also be sent to all acting officials and invited NFs.

In accordance with Article 110.1 and 110.2 of the General Regulations, alterations to the Definite Schedule(s) must be presented to the FEI for approval and be notified to all invited NFs. No changes may be made to the schedule(s) within two weeks prior to the start of the event.

Furthermore, we look forward to receiving within five days after the event(s) (Art. 109.6 FEI GRs):

- one copy of the programme,
- the detailed results of each of the international competitions (in percentage with 3 decimals), with the prize money distributed to each place and rider in each competition, awarded on the basis of one prize for every four starters with a minimum of five prizes, complete with rider ID numbers and horse FEI passport numbers.

If more convenient for the IT provider of the event, the results may also be provided as an XML file: <http://www.fei.org/disciplines/officials->

OCs that do not submit their results with prize money distributed, rider ID numbers and horse passport numbers on time (or incomplete results / prize money distributed) to the FEI will be invoiced CHF 1'000.- in addition to the amount for organizing dues (Art. 109.6 FEI GRs).

According to the Dressage Rules Art 437.9, at CDIs3* one Candidate Judge should be invited to judge in the Big Tour.

Please note that the Appeal Committee reports will no longer be systematically sent out. If an Appeal Committee report is needed, it can be downloaded from the FEI website. Upon completion the report should be returned to the FEI Legal department.
